Community Outreach and Engagement Plan [HB516/SB551]

The Director of DCR, jointly with the Director of DOI [DEI], and in coordination with the Chief Resilience Officer (CRO) and Special Assistant to the Governor to Coastal Adaptation and Protection (SACAP) shall prepare a **Community Outreach** and **Engagement Plan** for updates to the Virginia Coastal Resilience Master Plan and for development and updates to the Virginia Flood Protection Master Plan (the Plans)

The outreach and engagement plan shall **strive** for meaningful involvement by ensuring that

- (i) affected and vulnerable community residents have **access and opportunity to participate** in the full cycle of the decision-making process about the development of and updates to the Plans, and
- (ii) **decision-makers shall seek out and consider such participation**, allowing the views and perspectives of community residents to shape and influence decisions.

The Department shall seek input to the Community Outreach and Engagement Plan from representatives of:

Virginia Indian tribes, community-based organizations, the public health sector, nongovernmental organizations, civil rights organizations, communities impacted by recurring flooding, and VDEM Equity Working Group.



- All levels of government






Goals and Objectives

Adopt a whole community approach to outreach and engagement.

- Empower citizens and stakeholders, especially those who live and work in flood hazard zones, to contribute local experience and knowledge to the resilience planning process.
- Provide planning resources and opportunities to residents and stakeholders to encourage ownership and responsibility in community led efforts to shape and influence decisions in the planning process.
- Ensure communities historically under represented in the planning process are engaged and have the opportunity to provide input.
- Eliminate barriers surrounding public engagement, including, but not limited to: language, time of day, location, mobility and accessibility.



Outreach and Engagement Methods





Action - Leverage Partnerships

- Coordinate with agencies and organizations to ensure outreach and engagements meet accessibility standards
- Leverage existing programs to meet people where they are.
- Provide adequate information to organizations ahead of time to allow full participation in the planning process.
