The meeting started at 9:16am. Capt. Tom Crabbs indicated that all future meetings will be held on the WebEx platform to facilitate public involvement. Mr. Bell gave an overview of the Conflict of Interest Act (COIA) and Freedom of Interest Act (FOIA), offering that he was available for additional assistance. He discussed COIA and FOIA penalties, timelines for access to public records, public meeting definitions, and tips to avoid inadvertent violations of FOIA provisions.
