IV. TAC Activity

Rear Admiral Ann Phillips introduced the contractor, Dewberry and Dr. Brian Batten, who will support the work of the Technical Advisory Committee.

V. Charter Discussion/Approval

Modest adjustments in framing of text to emphasize economic development opportunity presented from resilience and adaptation to climate change

Introduction of critical role of financing, access to capital, and cash flow needs to implement cost-reimbursable economic development grants as barriers to economic development. Barriers that could present disproportionate obstacles to less wealthy communities. Adjustments were made to the Definition: Economic Development section to acknowledge the challenge and ensue the subcommittee address in the final deliverable.

The Charter was accepted as a working document and general guidance to the subcommittee and thus it did not need to be formally adopted by motion and vote of the subcommittee.

VI. Stakeholder List

DHCD had compiled a list of economic development agencies and stakeholders at the state, regional and local level. Proposed to survey the stakeholder list to assess their current level of awareness of the Coastal Master Plan Principles and whether those principles are being considered in economic development decision making now.

VII. Baseline Stakeholder Survey Discussion

Discussion about the value of surveying businesses in the coastal zone currently vulnerable to climate change. Subcommittee decided that would be a second phase of assessment and might be better suited for the business engagement activities in the forthcoming GO Virginia award to Virginia Sea Grant, RISE, Middle Peninsula Public Access Authority, and Old Dominion University.

Action Item: Emily Steinhilber – ODU will work with Sara Dunnigan – DHCD to draft a questionnaire for the economic development stakeholder list to assess awareness levels and current consideration of Coastal Master Plan Principles by economic development stakeholders. Draft questionnaire will be circulated to the subcommittee, Ann Phillips, and Dewberry.
