Welcome to Pocahontas State Park Campground Regulations

The following guidelines have been established to ensure your safe and enjoyable camping experience, and to protect this valuable resource:

- PUBLIC USE OF ALCOHOLIC BEVERAGES IS PROHIBITED BY STATE LAW AND ALLOWED ONLY INSIDE YOUR TENT OR CAMPER.
- QUIET HOURS ARE FROM 10:00 PM TO 6:00 AM. USE OF RADIOS AND OTHER DISRUPTIVE ACTIVITIES ARE PROHIBITED DURING THIS TIME.
- You must be at least 18 years old with proof of age to rent a campsite. The individual renting the campsite is the responsible party for adhering to all rules and regulations.
- Campsite fees entitle campers to the use of one campsite for a maximum of six (6) people.
- Only two (2) vehicles per site are allowed. Additional vehicles must pay the daily parking fee and must be parked in the overflow parking areas. Site tag and vehicle camping pass must be displayed at all times.
- All camping equipment, including vehicles and trailers, must be placed on the designated campsite. Parking on the grass or over landscaped timbers is prohibited.
- Check-in time for campsites is 4:00 PM, early check-in may be allowed when campsites are ready. Check-out is 1:00 PM, additional fees will be assessed for late check-outs. Check-in time for Camping Cabins/Yurts is 4:00 PM. Check-out time for Camping Cabins/Yurts is 10:00 AM.
- All pets must be confined within your campsite or restrained on a leash not longer than six (6) feet in length. Owners must attend to their pets at all times.
- Emptying holding tanks, including grey water, on the ground is illegal. A dump station is provided at the campground entrance for your convenience.
- Park regulations prohibit the cutting, marring, or removal of plants and trees. Nailing or screwing any object into trees or any other structure is prohibited.
- Properly dispose of all trash. The dumpsters are located close to the bathhouses in the campground, and at the dump station on the campground road. There is also a RECYCLE dumpster on the campground road.
- Fires are permitted only in the fire rings provided. Please properly extinguish all fires before departure.
